### V. Committee Reports

- FINANCE: Committee has not met. Treasurer Paul Chandler shared reports from May, June, July. First time KXCI assets have topped \$1M, due to Payroll Protection Program loan. Average donation income \$34K per month. The key financial documents are the balance sheet and the statement of activities.
- DEVELOPMENT: Committee will need a new chair. Cathy and Amanda will address that.
- GOVERNANCE: Committee has been waiting on legal counsel. Cathy will follow up regarding assignment of another attorney. MARKETING: Gwen is

the new chair. Committee met in March: New image for merchandise based on Bridgette Thum's design, and social media policy.

- CAB (Community Advisory Board). Need to appoint a new head or liaison from the board.
- WHERE DO WE LIVE: Zack shared results of staff survey with board: AC, heating and parking are concerns, as well as maintenance costs of the Armory Park studio. Committee will meet in September.

#### **VI. Executive Director Report**

- Executive Director Cathy Rivers discussed revenue from PPP loan, losses from underwriting. Leah can write a message for board members to share on social media re: underwriting opportunities. KXCI staff (Duncan, Amanda, Cathy) were able to report timely updates regarding Big Horn Fire and evacuation orders, safeguarding transmitter. New streaming service being tested. Amanda fixed the phones!
- KXCI received a Copper Cactus award nomination for "Innovation in Remote Working." (Results October 17)
- KXCI received nominations for Tucson Weekly's Best Radio Station and Best DJ (Hannah Levin)
- Remote interns this year. Now offering paid internship through International Broadcasters Association.
- Remote training and equipment to keep moving forward with diversity of on-air voices — grant/budget for microphones and computers.
